 - (2) a natural person while in the regular service of the ASSURED at any of the ASSURED'S premises and compensated directly by the ASSURED through its payroll system and subject to the United States Internal Revenue Service Form W-2 or equivalent income reporting plans of other countries, and whom the ASSURED has the right to control and direct both as to the result to be accomplished and details and means by which such result is accomplished in the performance of such service,
 - (3) a guest student pursuing studies or performing duties in any of the ASSURED'S premises,
 - (4) an attorney retained by the ASSURED and an employee of such attorney while either is performing legal services for the ASSURED,

- a. which is not an "affiliated person" (as defined in Section 2(a) of the Investment Company Act of 1940) of an **Investment Company** or of the investment advisor or underwriter (distributor) of such **Investment Company**, or
- b. which is a "bank" (as defined in Section 2(a) of the Investment Company Act of 1940).

This Bond does not afford coverage in favor of the employers of persons as set forth in e. FURTHER RESOLVED, that the officers of each Fund be, and each of them hereby is, authorized and directed to cause each Fund to pay its ratable allocation of the annual premium payable with respect to the Fidelity Bond and to enter into and execute, on behalf of the Funds, an agreement reflecting the provisions of the Fidelity Bond and relating to the sharing of premiums and division of proceeds in the event of a joint fidelity loss, as required by Rule 17g-1(f); and it is

FURTHER RESOLVED, that the officers of each Fund be, and hereby are, authorized to make filings with the SEC, in consultation with the Funds' legal counsel, and to give notices as may be required, from time to time, pursuant to Rule 17g-1(g) and Rule 17g-1(h) under the 1940 Act; and it is

JOINT FIDELITY BOND AGREEMENT

This Agreement is made as of this 1st day of January, 2015 by and among MainStay DefinedTerm Municipal Opportunities Fund, The MainStay Funds, MainStay Funds Trust, MainStay VP Funds Trust, Private Advisors Alternative Strategies Master Fund, and Private Advisors Alternative Strategies Fund on behalf of each of their series (the "Funds").

WITNESSETH:

WHEREAS, The Funds are management investment companies registered under the Investment Company Act of 1940 ("1940 Act"); and

WHEREAS, each Fund, on behalf of its series, must purchase a bond as required by the 1940 Act and Rule 17g-1 promulgated thereunder under which each such series is a named insured; and

WHEREAS, Rule 17g-1 requires that the named insureds under such a bond enter into an agreement with respect to certain matters;

NOW THEREFORE, in consideration of the premises and the terms and provisions hereinafter set forth, the parties hereto agree as follows:

1. <u>Description of Bond</u>. Federal Insurance Company of the Chubb Group of Insurance Companies, a reputable fidelity insurance company authorized to do business in New York, has issued a joint fidelity bond in the amount of \$9,050,000 (which may be increased from time to time) which designates each of the Funds and their series as named insureds ("Bond").

2. <u>Minimum Recovery</u>. In the event recovery is received under the Bond as a result of loss sustained by the Funds, each Fund shall receive an equitable and proportionate share of the recovery which shall be at least equal to the amount which each Fund would have received had it provided and maintained a single insured bond with the minimum coverage required by Rule 17g-1(d)(1).

3. <u>Term</u>. The term of this Agreement shall commence on the date hereof and shall terminate upon the termination or cancellation of the Bond.
