Hangzhou Steam Turbine Co., Ltd. Announcement on the progress of the relocation project

I. The situation of receiving compensation for relocation

The Company recently received the relocation compensation of RMB 69,725,732.78, and as of the announcement date the Company has received an aggregated relocation compensation of RMB 306,793,224.24.

II. The composition of the compensation for the relocation of physical assets

On March 21, 2018, the company held the 19th meeting of the 7th Board of Directors, in which the Proposal on the Company's Proposal to Sign the Relocation Compensation Agreement with Hangzhou Xiacheng City Construction Investment Development Group Co., Ltd was reviewed and passed, and the Company disclosed the Announcement on Hangzhou Steam Turbine Co., Ltd. of Signing the Relocation Compensation Agreement (Announcement No.: 2018-10)

The company signed the "Compensation Agreement for the Relocation of Non-residential Houses on State-owned Land" with Hangzhou Xiacheng City Construction Investment Development Group Co., Ltd. The company received a total of RMB 1,299,324,850 for relocation compensation; the company's holding subsidiary Hangzhou Steam Turbine Machinery Equipment Co., Ltd. received a total of compensation of RMB 6,625,450. The amount of compensation for relocation is the all compensation fess including the compensation for physical assets such as buildings, structures, house decoration, equipment and land within the scope of relocation of the Company and the Machinery Company, personnel resettlement fees; loss of shutdown and incentive expenses.

III. The legal basis for the relocation compensation matters

According to the "Asset appraisal report of asset portfolio assessment project involved in the compensation for enterprise relocation of Hangzhou Steam Turbine Co., Ltd. of No. 357 Land Shiqiao

Road" (No. 606—2017 Kunyuan Appraisal Report) issued by the Kunyuan Asset Appraisal Co., Ltd., the compensation amount for physical assets is RMB 882,988,430.00, thereinto: building compensation of RMB 224,084,400, decoration compensation of RMB 24,522,910, equipment compensation of RMB 165, 061, 120, and land assets compensation of RMB 469,320,000.

According to the appraisal report, the laws and regulations applicable to the appraisal for the relocation compensation are as follows:
