INTRODUCTION

The Opinion is based on the results of legal audit by K&A Legal LLC (the "Firm") of documents and information with respect to Altynken Limited Liability Company (the "Company") and its economic activities in the Kyrgyz Republic (the "KR"). The audit was conducted at the request of the Client for the purpose of the proposed listing of the shares of the Client on The Stock Exchange of Hong Kong Limited (the "Proposed Listing").

The Firm is a law firm duly qualified and experienced to provide legal services under the laws of the Kyrgyz Republic (the "Kyrgyz Laws"). Accordingly, the Firm has conducted a legal audit of the Company's activities strictly within the framework of Kyrgyz Laws and solely to the extent defined by the scope of work set out in the agreement concluded between the Client and the Firm on 21 May 2025. The Firm has not performed any financial, tax, geological, technical, or other types of assessments beyond the legal review, as it does not possess the requisite expertise, knowledge, experience, or qualifications in those areas.

The opinions contained in the Opinion are based entirely on the information and documents provided to the Firm as listed in Annex 1 to this Report (the "**Documents**").

The conclusions set out in the Opinion represent the professional opinion of the Firm from the legal perspective only and, for the avoidance of doubt, are not binding, indisputable, or obligatory for governmental authorities or officials, and for other consultants, experts, or specialists.

The Opinion is for the Addressees' own benefit. It may be relied upon by the Addressees and may be used in connection with the Proposed Listing. The Firm hereby consents to the disclosure and/or delivery of the Opinion if and to the extent such disclosure and/or delivery is:

- a) required for satisfying the relevant conditions in the underwriting agreements entered into in connection with the Proposed Listing;
- b) made to the affiliates and/or professional advisers of the Addressees;
- c) required by applicable law, regulations or rules (including but not limited to the Rules of Listing of Securities on The Stock Exchange of Hong Kong Limited); or
- d) required for seeking to establish any defence in any legal, regulatory or judicial proceeding or investigation.

OPINION

A. DUE INCORPORATION AND CORPORATE INFORMATION

a) Legal Status of the Company

i. <u>Establishment, Registration and Re-Registration of the Company with the Justice Authorities</u>

The Company was duly incorporated on April 5, 2006, as a limited liability company (registration number being 22968-3308-OOO, taxpayer identification number (TIN) being 00504200610034, and General Classifier of Enterprises and Organizations (GCEO) code being 24165384).

As of the date of the Opinion, the Company is in good standing (i.e. not in the process of liquidation, bankruptcy or reorganization) and validly exists under the Law of the Kyrgyz Republic "On business partnerships and companies" dated November 15, 1996.

On October 10, 2011, the Company was re-registered with the justice authorities due to a change of the participant.

ii. Legal Status of the Company

The Company is a separate legal entity which can sue and be sued in its own name and is not entitled to immunity under Kyrgyz Laws.

The Company has the requisite corporate and legal capacity to own, use, lease or operate its properties and assets and carry on its current business under Kyrgyz Laws and its constitutional documents, and there are no restrictions under the Company's constitutional documents affecting such ability, power and capacity.

iii. Constituent Documents

The constituent documents of the Company are compliant with Kyrgyz Laws.

iv. Charter Capital

There is no requirement in Kyrgyz Laws for the minimum charter capital of limited liability companies.

The charter capital of the Company is amounted to KGS 10,000 (ten thousand) and there is no indication that the charter capital had not been fully paid pursuant to Kyrgyz Laws.

The distributions of the participatory interests have been duly authorized, and the participatory interests have been validly distributed, and all such participatory interests rank equally in all respects. No consent, approval or authorization of, or filing, registration or qualification with, any court, governmental or regulatory authority is required under Kyrgyz Laws with respect to the distributions of the participatory interests.

The liability of each participant in respect of the Company is limited to the capital represented by its participatory interests.

There are no known charges, security, liens, encumbrances, equities or claims over the participatory interest.

There is no concept with respect to rights, warrants or options to acquire, or instruments convertible into, any participatory interest in limited liability companies under Kyrgyz Laws.

The current and historical participatory structures (including all changes to such structures) have been lawful and validly approved and recorded. All participants in the Company are properly qualified to be participants under the Company's constituent documents and Kyrgyz Laws.

All required filings and stamp duties related to replenishments and transfers of charter capital have been fulfilled.

v. <u>Legal Address</u>

The Company has its registered office at 18, Kudryashov Street, Orlovka town, Kemin district, Chuy region, Kyrgyz Republic.

b) Founders / Participants of the Company

Currently a disposal of the participatory interests in the Company is subject to the following:

- b. (if the non-selling participant has waived its preemptive right as mentioned above) a preemptive right of the Cabinet of Ministers pursuant to Kyrgyz Laws.

A pledge of the participatory interests in the Company is subject to (a) the consent of the other participant (if such other participant is the pledgeholder) or (b) the approval at a general meeting of the participants (if the third party is the pledgeholder).

c) Board of Directors

A limited liability company may elect to establish or not to establish a board of directors under Kyrgyz Laws. The Company has validly established a board of directors since 2023 in compliance with its constituent documents and Kyrgyz Laws, comprising:

- a. Mr. Shen Quansheng
- b. Mr. Liao Jiansheng
- c. Mr. Yu Mingshu
- d. Mr. Bakirov S.K.
- e. Mr. Kulbarakov R.D.

d) Branches, Representative Offices and Subsidiaries

The Company has no branches, representative offices or subsidiaries.

e) Dividend Payments

The Company has full power and authority under Kyrgyz Laws and the Company's constituent documents to declare and effect dividend payments in and out of Kyrgyzstan in local and foreign currencies, provided that (1) the formality requirements have been complied with and (2) such payments would not result in a breach of the Company's existing payment obligations.

Dividend payments are subject to applicable tax withholding in accordance with Kyrgyz Laws and can be declared and effected without the necessity of obtaining any governmental approvals or permits.

No foreign exchange or profit repatriation restrictions exist under Kyrgyz Laws.

f) Borrowings

The Company may make borrowings provided that internal approval has been obtained.

B. ACQUISITION OF THE COMPANY BY THE CLIENT

The acquisition of 60% participatory interest by the Client (through SPL) was duly authorized, with the underlying agreements relating to such acquisition being duly executed and enforceable under Kyrgyz Laws.

C. MINING OPERATIONS

a) Licence for the Right to Use Mineral Resources

i. <u>Licence Issuance</u>

The Company has obtained the necessary licence for its mining activities in compliance with Kyrgyz Laws. The information of such licence (the "Licence") is as follows:

The Licence is true, legal, valid and in good standing. There is no known limitation, restriction, third-party claim or other factor which will or may affect the validity of the rights thereunder.

ii. <u>Licence Agreement and Other Material Agreements</u>

Licence Agreements

Licence agreement(s) are an integral part of the Licence. The licence agreement under which the Company is operating is duly authorized, executed and enforceable in accordance with Kyrgyz Laws. It does not contravene any applicable Kyrgyz Laws or the constituent documents of the Company.

Other Material Agreements related to Mining Operations

All of the Company's material agreements relating to mining operations (as set out in Annex 2 hereto) are valid and enforceable.

Encumbrance (pledge) over the Licence

There is no registered pledge over the Licence pursuant to the Ministry of Natural Resources. Any unregistered pledge over the Licence is invalid under Kyrgyz Laws.

iii. Confirmation of the fulfilment of the licensing terms by the Mining Regulator

The Company is in compliance with the terms of the Licence and there are no grounds for termination (annulment) of the Licence.

b) Environmental, Social and Governance Matters

There are no non-compliance issues or penalties related to (a) the environmental, social and governance aspects or (b) the applicable rehabilitation requirements under Kyrgyz Laws.

There are no material risks related to community disputes or environmental liabilities.

There are no known issues involving informal miners concerning the Company's mines; if any such issue arises, remedies and state obligations may be asserted by the Company under applicable Kyrgyz Laws.

D. LEGAL COMPLIANCE – LICENCES AND PERMITS

a) Government Authorizations

The Company holds all necessary licences and permits issued by the competent regulatory authorities in the KR in support of its mining operations (the "Government Authorizations"), as set out below.

All Government Authorizations are in full force and effect and granted under normal terms, and there are no material legal impediments to their renewal. The Company has not received any notice of any proceedings relating to the revocation, suspension, withdrawal, cancellation, or modification of any such Government Authorizations.

b) Compliance with Laws

All necessary corporate and regulatory filings have been made on a timely basis as required by Kyrgyz Laws. There is no other filing, recording or registration with any governmental or regulatory authority in Kyrgyzstan that has not been effected in connection with the Company's operations in any material respect.

The Company is in compliance with Kyrgyz Laws in all material respects.

E. INSOLVENCY AND LITIGATION

There is no order or filing for the winding-up, dissolution or liquidation of the Company or appointment of an administrator in connection with the winding-up, dissolution, liquidation procedures of the Company or its assets.

There is no litigation, bankruptcy, winding-up, prosecution, arbitral or disciplinary proceeding involving the Company or its legal representatives or senior management which may have a material adverse impact on the Company.

There are no current or pending complaints, investigations or regulatory proceedings by or involving the Company, its legal representatives or senior management which may have a material adverse impact on the Company.

There are no (1) government fines or penalties against the Company which may have a material adverse impact on the Company, or (2) criminal records of the Company.

F. PROPOSED LISTING OF THE CLIENT

a) Approvals, Authorisations, Consents, Filings or Notifications with Kyrgyz Authorities

Under Kyrgyz Laws, the Company is not required to obtain approvals, authorizations or consents from Kyrgyz state authorities nor notify them in respect of the Proposed Listing of the Client.

b) Conflicts with Kyrgyz Law, Corporate Charter or Binding Agreements

The Proposed Listing of the Client, by itself, does not conflict with (1) the Company's constituent documents or (2) Kyrgyz Laws applicable and relevant to the Company.

The Proposed Listing of the Client is not expected to constitute a default or violation of the Material Contracts (as defined below).

G. TAX AND ROYALTY

a) Payment of applicable taxes by the Company

The Company has duly submitted tax reports and declarations and has paid all applicable taxes. There are no tax arrears which may have a material adverse impact on the Company.

The Company is subject to royalty payments on the extraction of gold, silver, and copper in accordance with Kyrgyz Laws, and has fully paid all royalties due from the year of 2022 to the date hereof. There are no known disputes relating to the royalty payments.

The Company does not benefit from any tax exemptions, reliefs, concessions, or other preferential treatments under Kyrgyz Laws.

b) Payment of other mandatory payments payable to governmental authorities

Under Kyrgyz Laws, the Company, as a mining company, is obliged to (1) pay local infrastructure development fee, licence retention fees, surface water usage fees and ecological fees for environmental pollution and waste disposal; and (2) finance reclamation activities through monthly contributions to special reclamation funds held in bank accounts. There is no known dispute, litigation and/or prosecution with or by the relevant governmental authorities in relation to these mandatory payments / contributions which may have a material adverse impact on the Company.

c) Compliance with Tax Law

The Company has complied with applicable Kyrgyz Laws on tax matters in all material respects and is not subject to any penalties/fines for violation of any applicable Kyrgyz Laws on taxation which may have a material adverse impact on the Company.

d) Transfer Pricing

There is no known transfer pricing issue raised in respect of the Company.

H. MATERIAL ASSETS AND INTELLECTUAL PROPERTIES

a) Material assets of the Company

There is no indication of any:

- 1. illegality or invalidity with respect to the Company's title to its material assets;
- 2. defects, claims or encumbrances over the material assets owned by the Company that are out of the ordinary course of the Company's business or that may have a material adverse impact on the Company; or
- 3. outstanding mortgages, charges, liens or other kinds of security granted over or registered against any of the material assets of the Company which are out of the ordinary course of the Company's business or which may have a material adverse impact on the Company.

b) Intellectual Property of the Company

The Company does not hold any registered intellectual property rights and is not subject to any claim relating to infringement of any other party's intellectual property rights.

c) Immunity

The Company does not assert, and is not entitled to, any immunity, whether on the grounds of sovereignty or otherwise, from legal action, enforcement proceedings, set-off, or counterclaim in respect of any of its assets or intellectual property (if it becomes an owner of the same).

With respect to each Material Contract not governed by Kyrgyz Laws, there is no indication that it is invalid or unenforceable.

There is no known default by the Company of any of its material obligations under the Material Contracts. No notice of breach, default, or intention to terminate has been received by the

Company from any counterparty. There are no known disputes or claims outstanding in relation to any of the Material Contracts.

References in the Opinion to Kyrgyz Laws are intended to refer solely to legislation of the Parliament of the Kyrgyz Republic, edicts, resolutions, orders of the President of the Kyrgyz Republic and resolutions, ordinances, regulations of the Cabinet of Ministers of the Kyrgyz Republic (the "Government" or the "Cabinet of Ministers") and other normative acts of the Kyrgyz Republic that are in force and effect as of the date of the Opinion, the full texts of which, together with their related implementing resolutions, are officially published and are readily accessible. We express no opinion as to resolutions, regulations, or orders promulgated by any authority of any province, district, or territorial subdivision of the Kyrgyz Republic and/or those not officially published and/or made available to public.

The Constitution of the Kyrgyz Republic does not clearly delineate the respective spheres of competence and jurisdiction of the legislative and executive branches of bodies of power and local self-governments in the Kyrgyz Republic and provides no strict hierarchy to resolve contradictions or inconsistencies that may arise between laws or other normative acts that are promulgated by such branches.
