## I. SCOPE OF OPINION

### 1.1. Introduction

We have acted as Colombian independent counsel to Continental in connection with the legal opinion required for the purpose of the proposed listing (the "**Proposed Listing**") of the shares of the Issuer on The Stock Exchange of Hong Kong Limited (the "**Opinion**").

### 1.2. Examination of Documents

In rendering the opinions set forth below, we have examined and relied upon examined copies, certified or otherwise identified to our satisfaction, of the documents set forth in the **Schedule 1.2** to this Opinion, which were submitted by Continental up to and including September 9, 2025, and which we considered necessary or relevant for purposes of the opinions expressed below (collectively, the "**Documents**"). Accordingly, our opinions are based solely on the Documents, and we express no opinion with respect to any matters that may be

affected by information that was not delivered, omitted, or not made available for our review.

### **1.3. Reliance and Disclosures**

The Opinion is for the Addressees' own benefit. It may be relied upon by the Addressees and may be used in connection with the Proposed Listing. We hereby consent to the disclosure and/or delivery of the Opinion if and to the extent such disclosure and/or delivery is:

- (a) required for satisfying the relevant conditions in the underwriting agreements entered into in connection with the Proposed Listing;
- (b) made to the affiliates and/or professional advisers of the Addressees;
- (c) required by applicable law, regulations or rules (including but not limited to the Rules of Listing of Securities on The Stock Exchange of Hong Kong Limited); or
- (d) required for seeking to establish any defense in any legal, regulatory or judicial proceeding or investigation.

### **II. ASSUMPTIONS AND LIMITATIONS**

- 2.1 With respect to all Documents examined by us, the genuineness of all signatures, the legal capacity of individuals signing any documents, the conformity to authentic original documents of all Documents submitted to us as telecopied or photocopied copies.
- 2.2 All public records of Continental which we have examined are complete, true and accurate.
- 2.3 The certificate of good standing with respect to Continental is conclusive evidence that it is duly established under the laws of Colombia and has not been dissolved.
- 2.4 The accuracy and completeness of all corporate minutes, resolutions, certificates, registers and corporate instruments we have seen remain in full force and effect.
- 2.5 We express no opinion as to any laws other than the laws of Colombia and we have assumed that there is nothing in any other laws that may affect the Opinion which is delivered based upon Colombian law applicable on the date hereof. Any subsequent changes of the laws of Colombia may potentially affect the Opinion in the terms stated below.

- 2.6 To the extent that an independent verification is not possible, all permits, licenses, and authorizations referenced in or relevant to the Documents are validly issued, subsisting, in full force and effect, and have not been revoked, suspended, terminated, or otherwise invalidated as of the date hereof.
- 2.7 All agreements referenced in or relevant to the Documents have not been terminated, amended, or rescinded, whether in whole or in part, as of the date hereof. We have assumed that all parties to such agreements (other than Continental) have complied, and will continue to comply, with their respective obligations thereunder.

## III. OPINION

Based upon the foregoing, and subject to the qualifications set out below and any matters not disclosed to us, it is our opinion that:

### A. Due Incorporation and Corporate Information

1. Continental was duly established on July 5<sup>th</sup>, 2007, and is in good standing, valid and existing under the laws of Colombia.
2. Continental is a branch of Continental Gold Limited ("CGL", a Bermudan company) and has its registered office at Carrera 43A #1-50 Of 1052 and 1152, Medellín, Colombia. It can sue and be sued in its own name and is not entitled to immunity under the laws of Colombia.
3. Continental's establishment is not in breach or violation of any laws or regulations of Colombia.
4. Continental has the requisite corporate and legal capacity to own, use, lease or operate its properties and assets and carry on its current business under the laws of Colombia and its establishment documents, and there are no restrictions under Continental's establishment documents affecting such ability, power and capacity.
5. Since the establishment of Continental and thereafter up to the date of the Opinion, the legal representatives of Continental (including all changes within such period) are as listed in **Schedule 5**, and they had or have been appointed in accordance with applicable laws and Continental's establishment documents.
6. Continental has full power and authority under the laws of Colombia and its establishment documents to declare and effect profit distributions in or out of Colombia;

- (i) freely in any foreign currencies,
  - (ii) without any withholding or other taxation except for those set out in **Section 58**,
  - (iii) freely transferable out of Colombia, and
  - (iv) without being subject to any restrictions, except as provided in **Section 7**, and without the necessity of obtaining any governmental approvals or permits.
7. The following restrictions (including any requirement for any approval, license or filing) apply to the repatriation of profits of, or foreign exchange controls affecting, Continental:
- (i) Profits must be based on fully audited end-of-year financial statements.
  - (ii) Continental's assigned capital must be paid through the Colombian foreign exchange market (i.e., through a foreign exchange market intermediary or channeled via a compensation account).
  - (iii) Continental must file a foreign exchange declaration for international investments with the Central Bank, either through its foreign exchange market intermediary (a Colombian bank) or directly if it holds a compensation account.
8. Continental's establishment documents stipulate no limitations or restrictions in respect of Continental's ability to incur debt or provide security (including with respect to the amount of borrowings).

## B. Mining Operations

9. Continental has obtained all necessary approvals for the mining activities conducted by Continental from the government and relevant authorities.
10. All mining concession agreements are currently valid. A list of such mining concession agreements is included in **Schedule 10**. There are no legal impediments in relation to the renewal of such mining concession agreements which may have a material adverse impact on the business operations and/or financial performance of Continental.
11. All exploration and exploitation rights owned by Continental under the mining concession agreements included in **Schedule 10** (the "**E&E Rights**") are true, legal, and valid without limitations or restrictions. Subject only to the pledges which are granted by Continental in its ordinary course of business and do not have any material adverse impact on the business operations and/or financial performance of

Continental, provided that Continental continues to perform its obligations under the agreements that such pledges are endorsing so that the pledges are not enforced, such E&E Rights are exclusively enjoyed by Continental, are in good standing, and no factor affects the validity of the rights or results in or may result in real or potential dispute.

12. With respect to all E&E Rights which have been acquired by Continental, the relevant acquisition agreements are (i) duly authorized, executed and enforceable in accordance with the laws of Colombia; and (ii) the acquisitions do not violate any applicable laws, regulations and constitution of the transferor and transferee.
13. So far as we are aware, there are no investigations pending against Continental for non-compliance with the authorized production volume under the work plans in connection with the relevant mining concession agreements.
14. Continental's mining activities at its mines materially comply with the relevant environmental laws and all other relevant regulations. Under the environmental licenses held by Continental, there are rehabilitation and compensation requirements, and there is no non-compliance by Continental.
15. There are no material risks related to community disputes or environmental liabilities.
16. Continental's material agreements related to mining operations as described in **Schedule 38** are legally valid, binding, and enforceable.
17. To our knowledge, Continental is subject to risks relating to informal miners who have been illegally extracting gold from within its concession. Continental is entitled to claim against the relevant Colombian government or authority over any lack of security guarantees for its operations in the country or other legitimate grounds.

## C. Legal Compliance – Licenses and Permits

18. Continental has obtained all necessary licenses, consents, authorizations, permissions, declarations, approvals, orders, registrations, clearances, certificates, permits, reports (the "**Government Authorizations**") to and filings with government agencies or body or any other regulator (the "**Authority**") in Colombia for it to own, lease, license and use properties (including any planning, building, construction and occupation permits and approvals) and assets, and to conduct its current business in so far as such properties

and assets and the conduct of such businesses are governed by the laws of Colombia. The information of such Government Authorizations is set out in **Schedule 18**.

19. The Government Authorizations are in full force and effect and contain no material restrictions or conditions. There are no legal impediments to their renewal, and Continental has not received any notice of any proceedings relating to the revocation, suspension, withdrawal, cancellation, or modification of any such Government Authorizations.
20. So far as we are aware, all necessary corporate filings have been made on a timely basis in Colombia since Continental's establishment and thereafter up to the date of the Opinion; no other filing, recording, or registration with any Authority in Colombia has not been effected in connection with Continental's operation.
21. Continental complies in all material respects with all applicable laws of Colombia.

## D. Insolvency and Litigation

22. Based on available searches with the relevant courts (or other applicable body) evidenced in **Schedule 22** (the "**Relevant Searches**"), there is no order, writ of summons, petition or shareholders' resolution filed or passed for the dissolution or liquidation of Continental or appointment of a receiver, administrator or liquidator in connection with the winding-up, dissolution, liquidation procedures of Continental or its assets.
23. Based on the Relevant Searches, there are no litigation, bankruptcy, winding-up, prosecution, arbitral or disciplinary proceedings involving Continental or its legal representatives or senior management which may have a material adverse impact on the business operations and/or financial performance of Continental.
24. Based on the Relevant Searches, there are no previous complaints or current investigations or regulatory proceedings by or involving Continental, its legal representatives or senior management which may have a material adverse impact on Continental.
25. There are no government fines, penalties or the like made against Continental or any criminal records of Continental.

## E. Proposed Listing of the Issuer

26. Continental does not require any approvals, authorizations or consents of and from, or filings with or notifications to any Authorities for or as a result of the Proposed Listing.
27. The consummation or performance of the transactions contemplated by the Proposed Listing will not contravene, violate, conflict with or constitute a default under:
  - (i) any law, regulation, judgement, ruling, order or decree of Colombia which is currently in force;
  - (ii) the establishment documents of Continental; or
  - (iii) any agreement/instrument binding upon Continental or any of its assets (in particular, the Material Contracts, as defined below).

## F. Tax and Royalty

28. No public search on tax filings is available in Colombia and, subject to the matters set out in **Schedule 28**, there is no indication that Continental has not filed its applicable tax returns, information reports or paid its taxes since its establishment.
29. To the best of our knowledge, all tax waivers, relief, concession and preferential treatment granted to Continental in Colombia are valid, binding and enforceable.
30. Subject to the matters set out in **Schedule 28**, Continental is not subject to any fines or penalties in Colombia regarding the compliance with the tax obligations.
31. To the best of our knowledge, Continental has not incurred any transfer pricing issue since its establishment.
32. Continental has no disputes, disagreements, or the like relating to the royalties and/or payments payable to governmental authorities in Colombia.

## G. Assets and Intellectual Property

33. There are no defects, claims, or encumbrances over the assets owned by Continental that are out of the ordinary course of Continental's business or that may have a material adverse impact on Continental.
34. There are no outstanding mortgages, charges, liens or other kinds of security granted over or registered against any of the assets of Continental which are out of the ordinary course of Continental's business or which may have a material adverse impact on Continental.

35. Continental has legal and valid title to all of its assets.
36. Continental has no rights of immunity on the grounds of sovereignty or otherwise from any legal action, suit or proceeding, from set-off or counterclaim, for any of Continental's assets/intellectual properties.
37. Continental does not own any intellectual property and is not subject to any claim relating to infringement of any other party's intellectual property rights.

## H. Material Contracts

38. The material contracts to which Continental is a party or which are binding upon it or any of its assets (the "**Material Contracts**") are listed in **Schedule 38**.
39. Each Material Contract has been duly authorized, executed, and delivered by Continental. With respect to each Material Contract governed by the laws of Colombia, it is legally valid, binding and enforceable, does not require any Government Authorization in respect of its execution, delivery or performance, and does not contravene any applicable laws and regulations in Colombia. With respect to each Material Contract not governed by the laws of Colombia, there is no indication that it is invalid, non-binding or unenforceable.
40. Continental is not known to have (a) been in default of any of its material obligations under the Material Contracts or (b) received any notice from any counterparties relating to any breach or default of the Material Contracts.

## I. Real Properties and Leases

41. The real properties owned by Continental are listed and described in **Schedule 41**.
42. There are no defects, encumbrances or outstanding security over any real property owned by Continental which are out of the ordinary course of Continental's business or which may have a material adverse impact on Continental.
43. There are no properties leased by Continental.

## J. Labor and Operation Safety

44. There has been no dispute, disturbance or other conflict between Continental and its employees which may have a material adverse impact on the business operations and/or financial performance of Continental.
45. Continental's sample employment contract form and content comply with Colombian laws.
46. Continental has (i) complied with all applicable operation safety, occupational health and work safety laws and regulations in all material respects, (ii) not been involved in any material incidents of work-related injuries or casualties which may have a material adverse impact on the business operations and/or financial performance of Continental, and (iii) not been notified of any claims for personal or property damages and compensation to its employees which may have a material adverse impact on the business operations and/or financial performance of Continental.

## K. Insurance

47. Continental is required to maintain insurance policies for its business and has duly maintained them according to Colombian laws.

## L. Compliance

48. Continental has complied with applicable anti-money laundering laws, anti-corruption and anti-bribery laws in Colombia in all material respects since establishment and thereafter up to the date of the Opinion. There is no public record or indication suggesting that Continental has violated or is currently exposed to enforcement action under OFAC sanctions or any other international sanction frameworks.

## M. Entrustment Operations Agreement and Return Swap Agreement

With respect to the business trusteeship agreement dated June 24, 2025, entered into by and between Continental and Gold Excellence Holdings Company Limited (the "**Entrustment Operations Agreement**") and the return swap agreement dated June 24, 2025, entered into by and between Gold Mountains (H.K.) International Mining Company Limited and Gold Excellence Holdings Company Limited (the "**Return Swap Agreement**"):

49. the arrangement as a whole is not in contravention of any legal or regulatory restrictions pursuant to Colombian laws and regulations, and there is no law or decision of Colombian courts explicitly invalidating such an arrangement or similar arrangements;

50. the arrangement does not require any notifications, registrations, filings, authorizations or approvals from the Colombian government or regulatory authorities;
51. the entry into such arrangement would not constitute a change of control of Continental under Colombian laws, and therefore would not trigger any notification or filing obligations or any need of approvals or reviews by the Colombian government or regulatory authorities;
52. the arrangement is consistent with the establishment documents of Continental;
53. the Entrustment Operations Agreement has been duly executed by Continental and is valid and enforceable in Colombia and against Continental if they were enforced in a Colombian court. With respect to the Return Swap Agreement, there is no indication that it is invalid, non-binding or unenforceable;
54. the implementation of the arrangement would not affect the validity of the licenses and qualifications or the mining rights which are relevant to the operations of Continental;
55. the entry into the Entrustment Operations Agreement and/or the Return Swap Agreement would not require any notification, filings or approvals from the Colombian governmental or regulatory authorities;
56. entering into the Return Swap Agreement would not give rise to any tax implications in Colombia, while entering into the Entrustment Operations Agreement may give rise to the following tax implications in Colombia:
  - a. considering that the value of the Entrustment Operations Agreement exceeds 6,000 UVT (COP 298,784,000 for 2025; approximately USD 70,000), it will be subject to the National Stamp Tax at a rate of 1%. Such National Stamp Tax is not applicable to the Return Swap Agreement, as this contract does not correspond to a sale or the provision of a service, nor does it create or modify obligations within Colombian territory;
  - b. with respect to the Entrustment Operations Agreement, the provision of services in the Colombian territory is considered Colombian-source income. Accordingly, such income is subject to income tax in Colombia and the payer must apply withholding tax for income tax purposes, in accordance with the applicable rate based on the classification of the service (generally 20%); and

- c. regarding the Entrustment Operations Agreement, the provision of services in Colombia also triggers the value-added tax at the general rate of 19% and Industry and Commerce Tax (ICA for its acronym in Spanish), levied by the municipality where the service is performed. The applicable ICA rate depends on the activity's classification;
- 57. under Colombian laws and regulations, Colombian governmental and regulatory authorities have no power to invalidate the Entrustment Operations Agreement and/or the Return Swap Agreement;
- 58. Continental is not restricted from making profit distribution to its parent entity, under the Colombian law and/or the establishment documents of Continental and Continental is not subject to any maximum amount of distribution of profits which it may declare. The transfer of profits attributed to a foreign entity's branch in Colombia to its related companies abroad is permitted and will be subject to the tax rules applicable to dividend distribution. Pursuant to Article 245 of the Colombian Tax Code, distributions of dividends to foreign entities will be taxed as follows:
  - a. if Continentals' profits have already been taxed at the standard 35% corporate income tax, the dividend distributed to its parent entity will be subject to a 20% withholding tax;
  - b. if Continentals' profits have not been taxed at the corporate level, the dividend distributed to its parent entity will be subject to the 35% corporate income tax, and a 20% withholding tax shall also be applicable on the remaining 65% of such dividend.
- 59. A dividend policy would need to be formally established by Continental such that dividends can be declared.
- 60. The recipients of dividend payment/distribution are not restricted from further transferring the distribution as per the Return Swap Agreement, under Colombian law and/or Continental's establishment documents.

**N. Relevant Sections of the Prospectus**

- 61. The statements in relation to Continental and the Colombian laws as set out in the prospectus dated September 19, 2025 in connection with the Proposed Listing (the "**Prospectus**") are true, accurate, complete and not misleading.

- 1.2 Wherever an opinion in the Opinion is qualified by the phrase "to our knowledge" or "so far as we are aware" with respect to the existence or absence, as the case may be, of facts, it is intended to indicate that during the course of our representation of Continental, except as expressly set out in the Opinion, we have not undertaken any independent investigation to determine the existence or absence of any facts and no inference as to our knowledge of the existence or absence of such facts should be drawn from the fact of our representation of Continental.

Based on the information included in the independent tax opinion issued by Martínez Quintero Mendoza González Laguado & De La Rosa on June 23, 2025 to Continental (the “**Tax Opinion**”), the Colombian tax authority (DIAN) initiated a tax audit against Continental in connection with the income tax return filing requirements in respect of an indirect transfer of ownership thereof to 2727957 Ontario Inc. (the “**Indirect Transfer**”).

As stated in the Tax Opinion:

- Pursuant to Articles 90-3 and 326 of the Colombian Tax Code (“**CTC**”), the indirect transferor involved in a taxable indirect transfer is required to file a tax return in Colombia within the month following the date of the indirect transfer.
- However, for the transfer of shares listed on a recognized stock exchange, only the indirect transferors which concentrate the same ultimate beneficial owner with more than 20% of the listed shares must file a tax return in Colombia.
- Through Official Tax Opinion No. 448 of 2019, the Colombian tax authority confirmed that there is no obligation to file an income tax return when the exception established under Paragraph 1 of Article 90-3 of the CTC applies.
- According to the documents reviewed for the purposes of the Tax Opinion, there are no shares concentrated in a single ultimate beneficial owner by more than 20%. Based on the foregoing, the Tax Opinion concludes that (1) the Indirect Transfer should not be subject to tax in Colombia for any of the indirect transferors as per paragraph 1 of Article 90-3 of the CTC and (2) the probability of any outflow resulting from any allegation to the contrary is remote.
