Coral Products PLC, a specialist in the design, manufacture and supply of injection moulded plastic products based in Wythenshawe, Manchester announces that, on 10 July 2023, it purchased 292,038 ordinary shares of 1 pence each (the "Buyback Shares") on the London Stock Exchange through Cenkos Securities PLC ("Cenkos"), in accordance with the terms of its share buyback programme announced on 10 July 2023 (the "Programme"). The Buyback Shares acquired will be held in treasury.
