Therefore, the total number of voting rights in the Company will be 372,278,875 and this figure may be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.

Since the commencement of the share buyback programme with Merrill Lynch International announced on 30 June 2023, the Company has repurchased 6,765,024 ordinary shares in aggregate at a weighted average price of 2,162.2736 pence per share.
