Corero generates c.\$2 million of orders in Q3 2023

- New customer: a communication service provider within the Southern Asian region. This order followed a successful Proof of Concept and strong commercial business case. The order comprises SmartWall DDoS protection solutions for 500Gbps of traffic throughout the region.
