Therefore, the total number of voting rights in the Company will be 366,841,899 and this figure may be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.

Since the commencement of the share buyback programme with Morgan Stanley & Co International Rc announced on 30 June 2023, the Company has repurchased 2,939,895 ordinary shares in aggregate at a weighted average price of 1,877.2900 pence per share.
