LG Electronics Inc. (the "Company") is pleased to announce certain unaudited operating statistics of the Company and its subsidiaries (the "Group") for the 3rd quarter of 2023 as follows.

In the 3rd quarter of 2023, the Group's consolidated sales amounted to KRW 20,713.9 billion (as compared to KRW 19,998.4 billion in 2023.2Q and KRW 21,176.8 billion in 2022.3Q), representing a quarter-on-quarter increase of 3.6% (QoQ 3.6%) and a year-on-year decrease of 2.2% (YoY -2.2%).

The Group's consolidated operating income amounted to KRW 996.7 billion (as compared to KRW 741.9 billion in 2023.2Q and KRW 746.6 billion in 2022.3Q), representing a quarter-on-quarter increase of 34.3% (QoQ 34.3%) and a year-on-year increase of 33.5% (YoY 33.5%).
