The Purchase was effected pursuant to instructions issued by Burberry on 29 June 2023, as announced on 30 June 2023.

Burberry intends to cancel the purchased shares.

Following the above transaction, Burberry holds 5,232,720 of its ordinary shares in treasury and has 358,543,029 ordinary shares in issue (excluding treasury shares).

Therefore, the total number of voting rights in the Company will be 358,543,029 and this figure may be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.

Since the commencement of the share buyback programme with Morgan Stanley & Co International Rc announced on 30 June 2023, the Company has repurchased 11,238,765 ordinary shares in aggregate at a weighted average price of 1,779.5500 pence per share.

These purchases are the last purchases to be made under the irrevocable programme between Burberry, on the one hand, and Morgan Stanley & Co International Rc, on the other hand, announced on the 30 June 2023, as that irrevocable programme has been completed in accordance with its terms.
