The purchased shares will be held in treasury. Following this purchase, the Company will have 292,282,541 ordinary shares in issue with voting rights and 16,346,000 ordinary shares held in treasury.

This figure 292,282,541 represents the total voting rights in the Company and may be used by Shareholders as the denominator for the calculations by which they can determine if they are required to notify their interest in, or a change to their interest in the Company under the Financial Conduct Authority's Disclosure Guidance and Transparency Rules.
