The Company hereby announces the conversion of an amount of £25,000 of the First Convertible Security issued on 6 December 2022, details of which were announced to the market on 7 December 2022. The First Convertible Security was issued pursuant to the Convertible Securities Issuance Deed dated 29 November 2022 as amended by a Deed of Amendment dated 2 June 2023, details of which were announced to the market on 30 November 2022 and 5 June 2023 respectively.

The Conversion Price is 0.02 pence per share and total of 125,000,000 new ordinary shares (the "Conversion Shares") fall to be issued.

Application will be made for the Conversion Shares to be admitted to trading on AIM. ("Admission"). Admission is expected to occur on or around Friday 8 March 2024.

Following the issue of the Conversion the face value of the First Convertible Security will be reduced to £125,000.
