Following the purchase, the number of Ordinary Shares in issue and admitted to trading on AIM will be 117,009,959 excluding shares held by Canaccord (being the "Total Share Capital"). Canaccord on behalf of the Company will hold 2,190,373 ordinary shares, representing approximately 1.872% per cent of the Total Share Capital.

This figure of 117,009,959 Ordinary Shares may be used by shareholders in the Company as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change in their interest in, the share capital of the Company under the Financial Conduct Authority's Disclosure Guidance and Transparency Rules.

The Company and Canaccord will make further announcements in due course following the completion of any further purchases pursuant to the Share Buyback Programme.
