**TRANSACTION IN OWN SHARES**

BAE Systems plc (the "**Company**") announces that, in accordance with the terms of its share repurchase programme announced on 28 July 2022 (the "**Buyback Programme**") and following the announcement on 1 June 2023 in relation to the initiation of the third tranche of the Buyback Programme (the "**Third Tranche**"), the Company purchased the following number of its ordinary shares of 2.5p each from Morgan Stanley & Co. International plc.
