The Company is pleased to announce the appointment of Mr Andrew Zychowski as an Independent Non-Executive Director of the Company, following an independent external recruitment process led by the Board's Nomination Committee. He is a qualified accountant and holds a BSc in Physics from Imperial College. Mr Zychowski is currently a Non-Executive Director of Middlefield Canadian Income PCC, and a Non-Executive Director of The Ralph Veterinary Referral Centre Plc.

Mr Zychowski and persons closely associated to him together hold 2,630,000 shares in the Company, or 0.3% of its share capital. In addition, other family members of Mr Zychowski hold 603,000 shares in the Company.

There are no other details that are required to be disclosed in respect of Rule 9.6.13 of the Financial Conduct Authority's Listing Rules.
