

**Wizz Air Holdings Plc

The SLGP Awards, which are one-off awards, will be subject to the following performance conditions:

(a) 100% of an award will vest subject to the Company's Share Price of £119.34 at the end of the Performance Period<sup>[11]</sup>. The threshold is a Company's Share Price of £77.24 for which 0% of the award vests with straight line vesting in between these two points. If prior to the end of the Performance Period, the Share Price Target is met or exceeded over any two consecutive quarters, based on the VWAP over that period, then in such case, subject to the Rules, the Award will vest in full on the Normal Vesting Date.

All vested options must be exercised within ten years of the date of grant. If exercised, then the underlying shares of the vested options will be issued at nil cost to the option holders. No amounts have been paid by the relevant PDMRs for the grant of these options.
