This disclosure reflects the fact that the voting rights effectively held indirectly by the underlying intermediate holding company abrdn Investments (Holdings) Limited ("aI(H)L") and held by the underlying investment management entity abrdn Investment Management Limited ("aIML") decreased below the 12% notifiable threshold due to trading on 1 July 2024. aI(H)L now effectively holds and aIML holds the delegated voting rights to 11.363922% of the shares in Hollywood Bowl Group plc. Prior to this crossing, aI(H)L effectively held and aIML held 12.067075% of the delegated voting rights.
