**Transaction in Own Shares**

Gulf Keystone, a leading independent operator and producer in the Kurdistan Region of Iraq, announces that on 11 July 2024, it purchased 125,000 common shares of US\$1.00 each in the Company ("Shares") on the London Stock Exchange through Canaccord Genuity Limited in accordance with the terms of its share buyback programme announced on 13 May 2024 and 21 June 2024 (the "Buyback Programme").

The repurchased Shares will be cancelled. Following the cancellation of the repurchased Shares, the Company will have 218,004,194 Shares in issue, with no Shares held in treasury. Therefore, the total number of Shares carrying voting rights will be 218,004,194.

The above figure of 218,004,194 may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
