Gulf Keystone, a leading independent operator and producer in the Kurdistan Region of Iraq, announces that on 23 July 2024, it purchased 141,311 common shares of US\$1.00 each in the Company ("Shares") on the London Stock Exchange through Canaccord Genuity Limited in accordance with the terms of its share buyback programme announced on 13 May 2024 and 21 June 2024 (the "Buyback Programme").
