Following settlement of the above transaction, Whitbread will hold 12,454,718 of its ordinary shares in treasury and has 191,882,488 ordinary shares in issue.

These purchases are the last purchases to be made under the irrevocable programme between Whitbread, on the one hand, and Morgan Stanley, on the other hand, announced on 30 April 2024, as that irrevocable programme has been completed.

Therefore, the total number of voting rights in Whitbread will be 179,427,770 and this figure may be used by shareholders as the denominator when determining whether they are required to notify their interest in, or a change to their interest in, Whitbread under the Financial Conduct Authority's Disclosure Guidance and Transparency Rules.
