Vertu Motors plc (AIM: VTU) announces that on 5 August 2024 it purchased 142,653 ordinary shares of 10p each in the Company (the "Repurchased Shares"), pursuant to the share buyback programme (the "Buyback Programme") that was announced on 15 May 2024, as follows (together the "Transaction"):

Following the cancellation of the Repurchased Shares, the total number of ordinary shares with voting rights will be 335,281,785 which may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, Vertu Motors under the FCA's Disclosure Guidance and Transparency Rules. The Company holds no shares in treasury.

The Company will make further announcements in due course following the completion of any further purchases pursuant to the Buyback Programme.

The Group currently operates 187 franchised sales outlets and 4 non-franchised sales operations from 144 locations across the UK.
