He was involved in extensive capital raisings, with over US\$4 billion raised across public and private markets and M&A, where he executed over US\$3 billion of acquisitions. Prior to his role at Wood Group, David was Group CFO of Jersey Oil and Gas plc, an AIM-quoted exploration company from 2011 to 2013.
