Therefore, the total voting rights in the Company will be 261,701,282. Since the commencement of the Share Buyback Programme to repurchase up to £50 million of Ordinary Shares, as announced on 4 December 2023, the Company has purchased 9,512,615 Ordinary Shares for a consideration of £44,586,989.90.
