IPF announces that on 28 August 2024 it purchased for cancellation from Peel Hunt the following number of its ordinary shares of 10p pence each on the London Stock Exchange pursuant to the authority granted by its shareholders as part of its share repurchase programme, details of which were announced on 31 July 2024.

The remaining 224,408,667 shares represents the total voting rights in the Company and may be used by shareholders as the denominator for the calculations by which they can determine if they are required to notify their interest in, or a change to their interest in, the Company under the Financial Conduct Authority's Disclosure and Transparency Rules.
