Update re. 1.05m Aerospace contract

As a result, once the U.S. Government approval has been obtained, it will trigger an immediate payment of 40% of the contract value.

Moreover, Ethernity's technical teams have been diligently collaborating to train and familiarize the Customer's personnel with the Company's technology, ensuring their readiness to further expedite the development progress once U.S. Government clearance has been granted.
