Wickes Group plc ("Wickes" or the "**Company**") announces today it has purchased the following number of its ordinary shares of 10 pence each through Peel Hunt LLP ("**Peel Hunt**").

The Company intends to cancel the purchased shares.

Following the purchase and cancellation of these shares, the Company's issued share capital will consist of 242,608,479. The Company does not hold any shares in Treasury.

Once the shares are cancelled, the total number of voting rights in Wickes will therefore be 242,608,479. This figure may be used by shareholders as the denominator for the calculations by which they can determine if they are required to notify their interest, or a change to their interest, in the Company under the Financial Conduct Authority's Disclosure and Transparency Rules.
