Once the shares are cancelled, the total number of voting rights in Wickes will therefore be 242,429,139. This figure may be used by shareholders as the denominator for the calculations by which they can determine if they are required to notify their interest, or a change to their interest, in the Company under the Financial Conduct Authority's Disclosure and Transparency Rules.
