Apax Global Alpha Limited ("AGA" or the "Company") announces that on 9 September 2024 it purchased the following ordinary shares (the "Ordinary Shares") on the London Stock Exchange through the Company's broker Jefferies International Limited ("Jefferies").

The total voting rights figure of 490,097,886 may be used by shareholders for the calculations by which they will determine if they are required to notify their major interest in, or a change to their major interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
