The Company holds 1,600,000 Ordinary Shares in Treasury and therefore the total number of Ordinary Shares with voting rights is 68,435,383.

The above figure of 68,435,383 may therefore be used by shareholders in the Company as the denominator for the calculations by which they will determine if they are required to notify their interest, or a change to their interest, in the Company under the FCA's Disclosure Guidance and Transparency Rules.
