Eurocell announces that it has purchased (through Berenberg acting as the Company's broker) the following number of its ordinary shares of 0.1p each on the London Stock Exchange.

43,490 purchased shares will be held as treasury shares and used to satisfy employee share options. The remaining 58,545 purchased shares will be cancelled, due to the Company having satisfied its requirement to acquire an additional 700,000 treasury shares for employee share schemes, as announced on 4 September 2024.
