The purchases form part of the Company's market equivalent of 250 million (being £196.7 million as at 18 June 2024) share buyback announced on 21 June 2024, which is the second, and final, stage of the Company's 500 million share buyback announced on 20 November 2023.

Following the above purchases, the Company holds 87,810,205 Ordinary Shares in treasury and has 1,697,593,772 Ordinary Shares in issue. Therefore, the total number of voting rights in the Company is 1,697,593,772 Ordinary Shares and this figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the Financial Conduct Authority's Disclosure Guidance and Transparency Rules.
