This disclosure also reflects the fact that the voting rights effectively held indirectly by the underlying intermediate holding company abrdn Investments (Holdings) Limited ("aI(H)L") and held by the underlying investment management entity abrdn Investment Management Limited ("aIML") decreased below the 11% notifiable threshold due to trading on 27 September. aI(H)L now effectively holds and aIML holds the delegated voting rights to 10.860878% of the shares in Hollywood Bowl Group PLC.
