Main elements impacting the quarter aggregates

- Hydrocarbon production is expected to be at 2.4 Mboe/d, thanks to the ramp up of the Mero 2 project in Brazil that partially offsets
 unplanned shutdowns in Ichthys LNG and security-related disruptions in Libya. Exploration & Production results are expected to reflect the
 decrease in liquid prices compensated by an increase in gas prices.
- Integrated LNG results are expected to be above 1 billion, in a context of low market volatility and a decrease in production due to unplanned maintenance on Ichthys LNG.
- Integrated Power results are expected to be broadly in line with the second quarter.
- Downstream results are expected to sharply decrease given much lower refining margins in Europe and in the Rest of the World.
