The cash amount of the shares purchased to 23 October 2024 as a result of the execution of the Buy-back Programme amounts to 688,938,592 Euros, which represents approximately 45.2% of the maximum investment amount of the Buy-back Programme. The programme was announced together with its other characteristics through the Buy-back Commencement Communication.
