In 2018 he was an integral part of the team that oversaw Codemasters' £280 million listing on the London Stock Exchange and in 2021 led the sale of the business to Electronic Arts Inc. for 1.2 hillion

Rashid is a Chartered Certified Accountant who trained with KPMG UK.
