**Vertu Motors plc ("Vertu Motors" or "Company")**

Vertu Motors announces that it was notified on 29 October 2024 of the following acquisition ("Dealing") of the Company's ordinary shares of 10p each ("Ordinary Shares") by Ocorian Limited ("Trustee"), the trustee of the Company's employee benefit trust. The Dealing took place on 29 October 2024 at a price of 66.2075 pence per Ordinary Share.

The acquired shares were purchased by the Trustee to be held for the purposes of the employee benefit trust and may be used to transfer shares to individuals when options are exercised. This will include the Company's Long Term Incentive Plan, under which each of the executive directors of the Company and other PDMRs are potential participants. They are therefore regarded as having a notional interest in the acquired shares.

The Group currently operates 198 franchised sales outlets and 4 non-franchised sales operations from 154 locations across the UK.
