### **Acquisition of Home Focus**

Dunelm Group plc ("Dunelm" or "the Group"), the UK's leading homewares retailer, announces that it has acquired Homefocus Group Limited ("the acquisition").

Homefocus Group Limited ("Home Focus") is a soft furnishings retailer which trades under the 'Home Focus at Hickeys' brand, with 13 stores trading in high-quality locations across the Republic of Ireland. The business also operates online, providing home delivery and a 'Click & Reserve' option for customers to collect products in-store. With a focus on fabrics, the brand specialises in specific home categories including curtains and bedding. We look forward to welcoming Home Focus' c.140 colleagues to the Dunelm family.

The acquisition is an attractive opportunity for Dunelm to connect with more customers by entering a new geography, with a homewares market of more than £1bn<sup>1</sup>. The acquisition immediately provides the Group with good coverage across the Republic of Ireland, through Home Focus' portfolio of smaller stores (<10,000 sq ft). Dunelm sees potential to offer a broader range of products in Home Focus stores, in line with the Group's existing smaller format stores in the UK, giving customers more choice and a more comprehensive offer for the home.

Dunelm also sees opportunity to introduce a more comprehensive online proposition and, over time, will assess new store opportunities across Ireland.

The acquisition will not be material to Dunelm's financial performance and the Group will utilise its existing operations, capabilities and supply partners to strengthen the customer offer of Home Focus.

*"In Home Focus we have found a high-quality and complementary business, with a shared heritage in home textiles and strong values which stem from family ownership. Dunelm is the UK's market leader in homewares with a purpose 'to help create the joy of truly feeling at home, now and for

generations to come'. Its specialist customer proposition offers value, quality, choice and style across an extensive range of c.85,000 products, spanning multiple homewares and furniture categories and including services such as Made to Measure window treatments.

The business was founded in 1979 by the Adderley family, beginning as a curtains stall on Leicester market before expanding its store footprint. The business has grown to 184 stores across the UK and has developed a successful online offer through dunelm.com which includes home delivery and Click & Collect options. 155 stores now include *Pausa* coffee shops, where customers can enjoy a range of hot and cold food and drinks.

From its textiles heritage in areas such as bedding, curtains, cushions, quilts and pillows, Dunelm has built a comprehensive offer as The Home of Homes including furniture, kitchenware, dining, lighting, outdoor, decoration and DIY. The business predominantly sells specialist own-brand products sourced from long-term, committed suppliers.

Dunelm is headquartered in Leicester and employs c.11,500 colleagues. It has been listed on the London Stock Exchange since October 2006 (DNLM.L) and the business has returned c.£1.5bn in distributions to shareholders since IPO.

The Home Focus at Hickeys brand offers a wide range of fabrics, ready-made curtains, curtain poles, blinds, bedding, haberdashery and craft supplies, alongside a bespoke Made to Measure curtains service.

The 13 Home Focus stores are located in Dublin (6 stores), Cork, Limerick, Galway, Kerry, Waterford, Wexford and Kilkenny.

The business has its head office and warehouse facilities located in Dublin.
