As part of the Programme, Citi purchases Vodafone (213800TB53ELEUKM7Q61) ordinary shares and sells such shares to Vodafone. In connection with the above purchases, on 25 November 2024 Citi (as riskless principal) elected to purchase 17,500,000 Vodafone ordinary shares to sell to Vodafone.
