Validation of SBTi targets Underpinning our commitment to reach Net Zero emissions by 2050

DFS Furniture plc ("DFS", the "Group"), the market leading retailer of living room and upholstered furniture in the United Kingdom, is pleased to announce The Science Based Targets initiative ("SBTi") has approved DFS Group's near-term sciencebased emissions reduction target. DFS has also committed to set long-term emissions reduction targets with the SBTi in line with climate science, to reach net-zero by 2050.

The submission sets out the Group's strategy and targets to reduce greenhouse gas ("GHG") emissions across the organisation and value chain and underpins the Group's commitment to minimising its environmental impact.

The Group's aim is to reduce absolute scope 1 and 2 GHG emissions by 90% by FY 2050¹. DFS has also committed to reducing absolute scope 3 GHG emissions 2 by 90% within the same timeframe.

In the near term, DFS has committed to reducing absolute scope 1 and 2 GHG emissions by 55% by FY 2033^{1} and, additionally, that 73% of Scope 3 GHG emissions² will have science-based targets by FY 2028.

The Group's Sofa Cycle framework, launched in 2020, ensures DFS takes a holistic view of its business's environmental impact and establishes an ambition to become a circular business. The framework considers operational, value chain, and end-of-life product impacts. This was the Group's first step towards developing a net-zero strategy, and working to establish long-term targets aligned with SBTi's net-zero criteria.

Tim Stacey, Group CEO: "We are delighted to announce that our ambitious near-term plans to reduce the Group's greenhouse gas emissions and our net-zero commitment have met the approval of SBTi's criteria.

"Our submission has been two years in the making and we recognise that this will be a long, and sometimes challenging journey. However, as market leaders, we have an obligation to lead from the front and we are committed to our role in helping transform the furniture industry's approach to net-zero.

"We feel even more confident in our plan due to the shared ambition and strong support we've received from our most trusted suppliers, the majority of whom have committed to come on the journey with us. Today's announcement validates that through the sheer determination of the DFS team, together with the openness and collaboration from our partners, we're a step closer to minimising our environmental impact and reaching net-zero by 2050."
