Ryanair Holdings plc (the "**Company**") today announces that on Tuesday, 3 December 2024 it purchased for cancellation a total of 65,850 ordinary shares of nominal value €0.006 each in the capital of the Company ("**Ordinary Shares**") and 114,000 Ordinary Shares underlying the American Depositary Shares, as further detailed below.
