On 10 December 2024, the Company repurchased 51,057 Ordinary Shares of USD 0.01 each in the capital of the Company designated as US Dollar shares (the "**USD Shares**") at a price of GBP 4.399284 per share. These shares will be held as treasury shares.

Following this, the total number of treasury shares held by the Company is 6,606,872 USD Shares and the number of shares in issue less those shares held in treasury is 144,251,363 USD Shares.

From 10 December 2024, the total number of voting rights in the Company is 144,251,363. This figure may be used by shareholders as the denominator for calculations to determine if they are required to notify their interest in, or a change to their interest in, the Company, under the FCA Disclosure Guidance and Transparency Rules.
