### Vesting of the Share Matching Scheme

EPE Special Opportunities Limited (the "Company") announces that, on 9 December 2024 in the offices of the Company's administrator, certain awards made under the Company's share matching scheme (the "Scheme") vested to certain members of the Board of Directors (the "Participants") (the "Vesting").
