Transaction in own shares

Further to the announcements made on 10 April 2024, 22 April 2024 and 29 July 2024, Tesco PLC (the "**Company**") announces that on 07 January 2025 it has purchased, in accordance with the authority granted by shareholders at the 2024 Annual General Meeting of the Company, the following number of ordinary shares of 6 1/3 pence on the *London Stock Exchange* pursuant to its existing £1 billion share buyback programme.

The purchased shares will be cancelled.
