#### IQE announces SBTi approval of emission reduction targets

- Approved targets in alignment with the Science Based Targets initiative
  - IQE on path to achieve Net Zero across operations by 2050

The SBTi's Target Validation Team has classified IQE's near and long-term targets as in line with this ambition and has also verified IQE's mitigation pathways for reaching Net Zero by 2050 or sooner.

"I am proud IQE's Net Zero targets have been validated by the SBTi. We have achieved the most ambitious designation available through the SBTi process, in recognition of the importance of achieving rapid and deep global greenhouse emissions cuts."
