## The Character Group plc ("Character", the "Company" or the "Group") Transaction in Own Shares

The figure of 18,673,091 may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
