Vistry Group PLC (the "**Company**"), announces that, in accordance with the terms of its share buyback programme announced on 12 September 2024 ("**Share Buyback Programme**"), the Company purchased the following number of its Ordinary 50p Shares ("Ordinary Shares") through Numis Securities Limited ("**Deutsche Numis**").

The purchased shares will be cancelled, following which the remaining number of Ordinary Shares in issue will be 331,624,058 with 600,097 shares held in Treasury. Therefore, the total voting rights in the Company will be 331,023,961.
