In reference to Section 9, the shares detailed are managed by the named discretionary investment management entity within multiple portfolios on behalf of underlying clients, based on investment management agreements whereby the client has delegated the exercise of the voting power to the referenced investment manager.

This disclosure also reflects the fact that the voting rights effectively held indirectly by the underlying intermediate holding company abrdn Investments (Holdings) Limited ("aI(H)L") and held by the underlying investment management entity abrdn Investment Management Limited ("aIML") decreased below the 10% notifiable threshold due to trading on 22 January 2025. aI(H)L now effectively holds and aIML holds the delegated voting rights to 9.392332% of the shares in Hollywood Bowl Group PLC. Prior to this crossing, aI(H)L effectively held and aIML held 10.337754% of the delegated voting rights.
