**Exercise of Options**

Redcentric plc (AIM: RCN) ("Redcentric" or the "Company"), a leading UK IT managed services provider, announces that it received notice of exercise ("Exercise") in relation to employee share options over 3,604 ordinary shares of 0.1p each in the Company ("Ordinary Shares") issued under the Company's Save As You Earn (SAYE) Option Plan 2014.

Accordingly, the Company has transferred 3,604 shares previously held in Treasury to satisfy the Exercise. As a result, the Company's issued share capital consists of 159,145,913 Ordinary Shares, 251,186 of which remain held in Treasury.
