### Board Changes

As part of these changes, it has been agreed that Graham Woolfman, the Company's Non-Executive Chairman, will step down with immediate effect and Neil Rafferty, a current Non-Executive Director, will be appointed as Interim Chairman. The process to recruit a new Chair with experience of the digital and sports development sectors will commence immediately.

I believe now is an appropriate stage in the Company's journey to step down from the Board and am pleased to continue to provide support during a period of recruitment and transition."
