Transaction in Own Shares

Epwin Group Plc(AIM: EPWN), announces that it has purchased ordinary shares of 0.05 pence each ("Ordinary Shares") in its issued share capital through Shore Capital in accordance with the terms of the share repurchase programme which was announced on 27 November 2023 and extended on 10 April 2024 and 11 September 2024 (the "Programme"), as follows:

Following cancellation, the Group's issued share capital will comprise 136,897,895 Ordinary Shares, each with one voting right. The Company holds no ordinary shares in treasury.

The total number of voting rights in the Group will therefore be 136,897,895. This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change in their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.
